Resolution No. 03: The IQAC has resolved that each Department should prepare the Departmental Profile by March next.

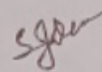
Resolution No. 04: The IQAC has discussed the importance of lesson plan in teaching-learning process and resolved that each department should prepare the lesson plan accordingly.
